(Arrival time must be at least 1 hour prior to the start of the ceremony). Includes 1 to 2 minute highlight video of your day as well as a full version video on a media drive.

GOLD PACKAGE (\$1200) 6 Hours

GOLD PACKAGE generally covers pre-wedding, the ceremony and reception. Includes 1 to 2 minute highlight video of your day as well as the full version video on a media drive.

PLATINUM PACKAGE (\$1600) 8 Hours

PLATINUM PACKAGE is ideal for full wedding coverage. Includes 2 to 4 minute highlight video of your day as well as the full version video on a personalized media drive.

ULTIMATE PACKAGE (\$2200) 12 Hours ■ 1 Add-On

ULTIMATE PACKAGE is ideal for full day wedding coverage. Includes 3 to 5 minute highlight video of your day as well as the full version video on a personalized media drive.

Select your add-on(s). Choose the number of add-ons included with the package you have selected, or add separately for \$300 each. You may change your add-ons choices up until 3 days prior to the wedding date.



TERMS AND CONDITIONS

A non-refundable deposit (25% of the package cost) is required in order to reserve Motion Productions (MP) services for the wedding date. The remaining balance will be due before the wedding date. MP will not begin filming until this payment is received. If the client cancels the contractual agreement prior to the wedding date, any money paid towards the balance with the exception of the deposit can be refunded.

The client is solely responsible for securing permission from the site owner/operator for use of the site to be filmed as well as authority for MP to set up all necessary production equipment. It is understood that the quality of the production is dependent upon adequate lighting, camera/microphone positions and other conditions not under the control of MP.

MP is not responsible for dark or grainy video resulting from inadequate lighting, refusal to use lighting at the site to its full capacity, the refusal of the client to allow camera-top lighting at the reception, or electrical or mechanical malfunctions on location that are beyond our control.

The agreement of the service is subject to proven detention by sudden illness, accidents, acts of God, or any other legitimate condition beyond the control of MP. Every reasonable attempt will be made to secure an alternate videographer in such an unlikely event.

Coverage hours included in the package are for the wedding date only and must be consecutive. This block of time includes set-up and teardown of equipment, transportation between venues and meal breaks.

MP reserves the right to discontinue videotaping in any situation (ex: rain, extreme temperatures, humidity, hazardous locations) that could put the safety of the videographer or equipment at risk.

The original tapes remain the property of MP. The client gives MP permission to use footage from the original tapes to market MP's wedding videography services. The client is responsible for obtaining permission to use any copyrighted music to be used in the wedding video.
